ACCELERATING TRAINING IN THE SAFE MANAGEMENT OFFICER (SMO) COURSE FOR CONSTRUCTION

We are expanding the training capacity for the SMO Course for Construction in the month of June 2020. A total of **40,000 training places** will be available in June 2020 for SMOs and Safe Distancing Officers (SDOs) in the construction sector.

In addition to BCA Academy and SCAL Academy, the SMO Course for Construction will be available at NTUC LearningHub from 15 June 2020 onwards. Participants from all three institutions will be recognised under BCA's COVID-Safe Restart Criteria. Where applicable, we will be contacting registered candidates on the availability of earlier dates for their training.
