**Subject: [Invitation] Industry demonstration workshop on new online reporting module (under EDMA) for EEOA (NV)**

Dear all,

As part of the enhancements to the Energy Conservation Act (ECA), new venture (NV) of any person (whether or not a registered corporation) under the ECA is required to carry out Energy Efficiency Opportunities Assessments (EEOAs) for business activity that satisfy the following requirements:

- a. Development Application to URA applied on or after 1 Oct 2018
- b. Business activity of NV is carried out at a single site and from one of the following industry sectors:
  - I. Manufacturing and manufacturing related services
  - II. Supply of electricity, gas, steam, compressed air and chilled water for air-conditioning
  - III. Water supply and sewage and waste management
- c. Estimated annual energy consumption of NV is  $\geq 54$  TJ based on 24 hours per day, 365 days of operations at 100% of design capacity

2 The detailed requirements of the EEOA on NV which came into operation on 1 Oct 2018 can be found in this [link](#). A new online reporting module under the Emissions Data Monitoring and Analysis (EDMA) system has been developed to facilitate the submission of EEOA (NV) reports.

3 To aid the industry practitioners and relevant stakeholders in familiarising with the new online reporting module, NEA will be conducting online demonstration workshops. The dates and times for each session, including workshop materials, are as follows:
