**CHOW KOK FONG** is a Chartered Arbitrator and currently practices as a mediator, arbitrator and adjudicator. He was previously CEO of Changi Airports International and of the Construction Industry Development Board and has held many other senior appointments with several large real estate and construction companies. He is Founder President of the Society of Project Managers, past Chairman of the Society of Construction Law and currently, chairs the Construction Adjudicators Accreditation Committee. Among his 19 books are the two-volume work Law and Practice of

Construction Contracts (up to 5thedition 2018); Security of Payments and Construction Adjudication (up to 2nd edition 2013) and the volume on Building and Construction Law in Halsbury's Laws of Singapore (2019). On 1 November 2013, he was awarded the quinquennial Singapore Academy of Law Award 2013 for contributions in promoting and advancing the development of Singapore law. In 2018, he was conferred a National Day Award for services to the Singapore Academy of Law.



**EDWIN LEE PENG KHOON** is one of the founding partners of Eldan Law LLP. He is accredited by the Singapore Academy of Law as a Senior Specialist in Construction Law. Edwin is a member of the SMC's Construction Adjudication Accreditation Committee, which oversees the selection, training and assessment of adjudicators. Edwin is also an accredited adjudicator in Malaysia. He has an active practice in construction law, conducting cases in court and in arbitration. Several of the leading constructions court cases argued by him include Lee Wee Lick Terence v Chua Say Eng, CAA Technologies

Pte Ltd v Newcon Builders Pte Ltd and Audi Construction Pte Ltd v Kian Hiap Construction Pte Ltd. Edwin is also an Adjunct Associate Professor with the National University of Singapore, and also lectures on construction law for the Building & Construction Authority Academy. He is the Construction Law editor for the Singapore Academy of Law's online journal the SAL Practitioner, and author of Building Contract Law in Singapore (Lexis Nexis, 3rd Ed, 2016).



**MELVIN CHAN is** a Partner in TSMP Law Corporation's Litigation and Dispute Resolution Department, and co-heads the Construction & Engineering practice, where he has extensive experience in contentious construction and engineering disputes, both in Court and arbitration. Melvin has successfully argued a number of landmark decisions in the High Court and Court of Appeal, including MCST Plan No 3322 v Mer Vue Developments Pte Ltd &Ors on the extension of the independent contractor defence to consultants and main contractors; Wei Siang Design

Construction Pte Ltd v Euro Assets Holdings (S) Pte Ltd, on the ambit of the consultants' duty of care to the employer; and more recently Denka Advantech Pte Ltd v Seraya Energy Pte Ltd, where the Court of Appeal reaffirmed the Dunlop test for liquidated damages. Melvin is an Accredited Adjudicator and a Fellow of the Singapore Institute of Arbitrators and is consistently recognised as a key practitioner for his work in Construction and Engineering in leading legal publications, including the Legal 500 Asia Pacific, Chambers Asia-Pacific, Asialaw Leading Lawyers, and Benchmark Litigation Asia-Pacific.



#### COVID19

Please be advised that vaccinated persons who can be exempted from PET are those who have completed the full vaccination regime where their <u>last dose</u> (being the second dose of the vaccination) is taken at <u>least 2</u> weeks before the event day. The second dose of vaccination being taken within the two weeks prior to event day does not exempt the attendee from PET; PET will then be required for the attendee. For those who are not vaccinated they have to take PET to allow attendance.



Attendees who have completed the full vaccination regimen in Singapore under the national vaccination program (i.e., using PSAR authorised vaccines) and have had sufficient time to develop sufficient protection (i.e., two weeks after the second dose of the Pfizer-BioNTech/Comirnaty or Moderna COVID-19 vaccination) will be exempted from PET. Your vaccination status will be displayed in your TraceTogether (TT) and HealthHub application. You will need to bring along your mobile device with call or internet service, or updated TraceTogether (TT) app on the day of the event, business, or activity. If you do not have a mobile device, please bring along you're working TraceTogether token
