Verify if the report belongs to the individual by checking against his/her Government-issued photo ID



# Physical Vaccination Card/Slip

Ensure that more than 2 weeks have passed since the final dose of the vaccine and that it belongs to the individual by checking against his/her Government-issued photo ID

# 3 Unvaccinated individuals who have recovered from COVID-19

## Pre-Event Testing (PET) exemption notice

Verify that the notice belongs to the individual by checking against his/her Government-issued photo ID and that the date of visit is within the validity period



#### Discharge Memo/ e-Discharge Memo

Verify that the notice belongs to the individual by checking against his/her Government-issued photo ID and that the duration of the activity is within the 180 days exemption period

(270 days exemption period will continue to apply only during the month of January 2022 as grace period)



Unvaccinated individuals who have recovered from COVID-19 and exceeded the 180-day period as at 1 January 2022, will have to be fully vaccinated by 31 January 2022 in order to enter VDS settings

# 4 Children aged 12 and below (i.e. born in or after 2010)

Children born in 2009 can still currently enter VDS settings, but from 1 March 2022, they will have to be fully vaccinated to continue doing so





#### Verify age for children

(establishments may exercise discretion)

## **Concessions only for**

Visits to and drop-off of children/elderly at licensed medical services, including registered TCM practitioners

Proof of appointment (e.g. letter, email, SMS or appointment card) is required for entry

Drop-off and pick-up at preschools/childcare centres

A letter of support from the preschool or childcare centre is required for entry
