Introduction

The WSH Council published the "Guidelines on Design for Safety in Buildings and Structures" as best practice in 2008 and kick-start the Train-The-Trainer (TTT) course by WSH Council and ESIS Asia Pacific Pte Ltd in the following year 2009. The first batch of Project Safety & Health Co-Ordinator (PSHC) received the competency certificate in Jul 2010. (*Note: The title of PSHC was changed to DfS Coordinator in 2011 and DfS Professional in 2015*).

The DfS guidelines has been revised and updated in 2011, 2016 and 2022. Although the DfS guidelines did not fall under the WSH (Approved codes of practice) Notification it is nevertheless an important document that provides the DfS outlines and template for Developer-Designer-Contractor (DDC) to kick-start the DfS planning for design and construction for any new project.

To benefit from DfS, we will require stakeholders (DDC) to think through the lifecycle stages of a building/construction project to eliminate or reduce the "design risk" right from the source with collective protective measures instead of personal protective measures (PPE).

We believe DfS is the ideal platform/tools for DDC to plan and design out the lifecycle risks. DDC will understand the important of eliminating/reducing the "design risks" as the "residual risks" which become the "construction risks" are likely to create safety & health impact on the affected persons. (I.e. Construction-maintenance-repair and demolition workers).

We believe the DfS will change the mindset of DDC and moving towards Vision Zero for sustainability.
