# Topic Synopsis

## **Evolution of ESG Reporting and Achieving Requirements in Real Estate Projects and Facilities Management**

The accelerated push for Sustainability and ESG necessitates deepening of the core knowledge of ESG among consultants and managers in the built environment, who directly contribute to the quality of our real estate space and by extension, to Singapore's national climate goals.

# Topic Synopsis

## **ESG in Built Environment and Sustainability Reporting**

The talk will cover the importance of measuring and reporting greenhouse gas emissions for the built environment, addressing both organisational greenhouse gas (GHG) reporting (Scope 1, 2 and 3 emissions) and product carbon footprinting. Differences between these, and how they could be used by businesses will be explained.

The relevance of Scope 1, 2 and 3 GHG metrics, or product carbon footprints for businesses in light of increasing green procurement practices will also be shared, as it may provide businesses with the competitive edge when it comes to supplier environmental evaluation in bids or tenders.

Topics covered:

- Organisational greenhouse gas reporting vs. product carbon footprint
- What are Scope 1, 2 and 3 greenhouse gas emissions
- What are climate related disclosures
- Examples of environmental related questions that could be asked as part of green procurement practices
