Seminar Information

Fire safety in Singapore is changing on several fronts. Requirements are being updated, compliance touchpoints restructured, and design approaches made more flexible. Each shift transfers more judgement to the professionals who design, certify and maintain buildings.

Audits and inspections keep surfacing the same non-compliances, caused less by unfamiliarity with the rules than by misread intent, construction-stage oversights, and assumptions carried over from earlier practice. Risks such as battery-related fires are outpacing the codes and the science.

This seminar addresses both. Regulators set out what has changed and why; practitioners and researchers show where things go wrong, drawing on audit findings and inspection cases, so participants leave better equipped to build resilience.
