Beyond Compliance: Building a Stronger RE/RTO Profession

This session explores the evolving role of construction supervision as Singapore moves towards Firm-Based Supervision and ISO/IEC 17020 adoption. It examines the professional competencies of REs and RTOs, the firm-level systems that support quality supervision, and the importance of fair procurement practices in strengthening construction quality, safety, and public confidence.
